

Further to my letter on September 26, 2018 we are pleased to report that the Plan of Survey we prepared on the above noted lands has been completed.

As previously reported, we found in our Land Registry Office research that these lands have been assigned the Property Identification Number (PIN) 45131-0437(LT) and are described as Lot 8 on Registered Plan No. 351.

In our research we found that plans had been prepared on Lots 7 & 8 in 1955 and a more recent one on Lot 7 in 1993. In the field we found survey bars marking the east limit of Lot 7 and the northeast corner of Lot 10.

We have used the location of the Survey Bars, buildings and information on the plans to help us re-establish the position of the Lot Lines.

The Plan by Ronald H. Smith O.L.S. on Lot 7 in 1993 re-established the limits of Lot 7. He accepted the position of the Chain Link Fencing as the best available evidence of the Lot Lines. We have used information on this plan to re-establish the south limit of your lot and the north limit of Lot 7.

We have found that Chain Link Fencing lies along the westerly limit and westerly portion of the northerly and southerly Lot Lines. Steel Fence Posts mark the southwest and northwest corners of the Lot.



The center of the Board Fence along the easterly portion of the southerly limit lies 0.14 m north at the west end of the fence and is 0.06 m south of the Lot Line at the east end.

We have shown perpendicular ties from the buildings to the Lot Lines.

We have set survey bars marking the Bend in the south limit and at the northeast corner of Lot 8.

Neither this report nor our plan is meant to in any way comment on zoning by-laws or building restrictions as they relate to this property.
